0102/16 APOLOGIES FOR ABSENCE were received from Councillor D England, Councillor J McClean, County Councillor B.R.A.D Watson (OBE) and Councillor Geoff Packham from Lower Beeding.

0202/16 DECLARATIONS OF INTEREST none.

0302/16 CHAIRMANS ANNOUNCEMENTS the Chairman made no announcements and no one present intended to record the meeting.

0402/16 PUBLIC FORUM

Mr C Equiis, the applicant for DC/16/0062, advised that prior to purchasing Monks Gate Cottage a lot of internal work had been carried out without Listed Building consent. Seeking advice from English Heritage a retrospective planning application has been submitted to 'wipe the slate clean', the applicant has also applied to move the positions of the gates.

Mr M Hoare requested further details of the TRO which is going to be implemented outside St Andrews School, the Clerk was asked to provide Mr M Hoare with a copy of the map detailing the proposed road markings.

Mr Fisher, the new owner of Harriots Cottage, asked if there was any further information on the meeting between the residents, Governors, WSCC and Parish Council? The Chairman advised that the meeting was going to be arranged by the Governors. Councillor J Chaytor commented that it was not agreed to have a meeting, only proposed and the matter had gone no further.

The Chairman advised that WSCC did not have the funds available to concrete the verge on the corner of Harriots Close.

At the recent MOGRA AGM a number of residents in Monks Gate asked if the boundary could be changed so that their properties were included in the parish of Nuthurst and not Lower Beeding.

The Chairman advised that this should be addressed when HDC reviewed their boundaries, the Parish Council will be consulted before there are any changes to district boundaries. The matter will be included on the 'Outstanding List'.

iii. PLANNING UPDATES

(a) Provide an update on the BUAB and SHELAA

The Chairman, District Councillor T Bradnum, Councillor O Hydes and Mr Boulter, the Chairman of MHAG, attended a meeting to discuss the SHELAA and Mannings Heath BUAB with Dr C Lyons, HDC Director of Planning.

The BUAB has been included in the Neighbourhood Plan and cannot now be changed, the plan will be reviewed in 5 years and the BUAB can be amended at this time.

HDC annually call for sites to be included in the SHELAA and the landowners can submit an application for consideration. This does not mean that development will take place, the applicant will still need to submit a planning application and under current government legislation if the site is not included in the Neighbourhood Plan HDC will not permit development.

There have been a considerable number of discrepancies in the 2015 SHELAA throughout the Parishes and HALC have advised that they should contact HDC.

(b) Provide an update on Woodlands Chase, Sedgwick Lane.

Although in Sedgwick Lane, the Woodland Chase development is not in the Parish of Nuthurst, the Clerk has reported the appalling condition of the lane to both the FNC Clerk and the HDC Enforcement Team. The Parish Council can do little more than ensure that the authorities are aware of the situation.

The applicant submitted a planning application for the construction of a wall on 23rd December 2015 and although planning permission has not been granted the construction of the wall has already commenced, again the Clerk has made the FNC Clerk aware.

District Councillor T Bradnum advised that she has passed the matter over to the FNC Councillor, the Tree Officer and Enforcement have both visited the site and the District Councillor will continue to chase up on behalf of the Sedgwick Lane residents.

iv. TREE WARDENS

Mrs P Bullen has been the Parish Tree Warden for a number of years and is assisted by Mr P Bullen. Mrs Bullen has undertaken training at HDC. To assist Mrs Bullen Councillor J Chaytor has volunteered to become a Tree Warden, undertaking training when available. **RESOLVED** for Mrs J Chaytor to become a Tree Warden for the Parish.

Action in Rural Sussex is organising the South East Neighbourhood Planning Roadshow, the aim of the roadshow is to increase the number of Neighbourhood Plans in rural communities. The event will be attended by the Minister for Housing and Planning and Nuthurst Parish has been asked to attend a give a presentation on their Neighbourhood Plan.

Councillor O Hydes and Mr R Webber have accepted the invitation to speak and will be making a presentation on Neighbourhood Plans on behalf of the Parish.

The Chairman advised that Lower Beeding Parish Council was also seeking the advice of Nuthurst Parish Council with their developing Neighbourhood Plan, Councillor O Hydes was unable to attend a recent meeting and the Chairman made a presentation at their meeting.

1202/16 LOCAL ASSOCIATION AND OTHER BODIES REPORTS

The recent HALC meeting was held in Mannings Heath Village Hall and Chris Stark, Area Highways Manager WSCC, and Sally Pavey, Communities Against Gatwick Noise and Emissions (CAGNE) were guest speakers.

Both presentations were extremely interesting and the Clerk was requested to circulate a recent report from CAGNE to the Councillors. The Clerk was also asked to see if a representative from CAGNE could make a presentation at the APM on 16th March 2016.

The HALC Conference, held in Southwater at the end of last year, was very successful and another conference will be arranged later in 2016.

The conference, scheduled for March 2016, on the Three Southern Counties (3SC) Devolution bid has been postponed for a few months.

The Chairman concluded, the role of PCSO's will be changing and a consultation is taking place at present.

A few residents in Monks Gate have been parking on the grass verges, outside their properties along the A281, the Clerk was asked to enquire who was responsible for repairing the damage which had been caused to the verges.

1602/16 ELECTORAL/BOUNDARY REVIEW

- i. To discuss the Parish Boundary
 - Any changes to the Parish Boundaries will be discussed when HDC review their boundaries.
- ii. To discuss the Electoral Review of West Sussex Draft Recommendations
 The implications of Electoral Review of West Sussex Draft Recommendations were
 discussed at length. The proposal would equalise the number of electors per County
 Councillor, however, the Parish would be split in two, with a County Councillor for each
 division. This would have a serious effect on Community Identity and the Councillors
 opposed the draft recommendation. Councillor J Mercer volunteered to write a draft letter of
 objection to the Local Government Boundary Commission for England, recommending that
 the whole Parish remained in the Southwater and Nuthurst Division.

Councillor O Hydes stated that the Electoral Review of WS Draft Recommendations would not affect the Neighbourhood Plan.

1702/16 ST ANDREWS SCHOOL

The plans for the TRO in Harriots Close are being processed by Balfour Beatty and although there is no definite date it has been suggested that the work may be carried out in the Easter Holidays.

The headmaster has written to the parents requesting for considerate parking and it is understood that the owner of Architectural Plants has agreed that the teachers can park in the bottom carpark. The proposal is being discussed by WSCC, the Headmaster and owner of the land.

There was an accident involving the school bus on Tuesday morning, fortunately the children were not seriously injured, the driver remains in hospital.
