2401/16 PUBLIC FORUM

Mr N Hatfield commented that for many years Park Lane had been characterised by mature Oaks trees, however, the applicant for DC/16/0022 had illegally felled the Oak trees in front of the Orchard and that they should be replaced with trees, not saplings.

The Chairman advised that if the trees were not covered by a TPO, or felling wood exceeding five cubic metres, the owner of the land could fell trees in their ownership. Mr W Jones, HDC Arboricultural Officer, has been advised that the trees had been felled.

Mr P Bullen stated that the trees were outside the boundary of the property, were not the applicants trees to fell and the essential character of Park Lane had been altered.
