I would like to take this opportunity to thank Jana Burton who was the Interim Director of Adults' Services during this period, for her leadership and development of the action plan. Jana has moved on from the County Council and I wish her well for the future. David Sargeant has now joined us as Interim Director of Adults' Services

and I look forward to working with him to take forward the ambitious plans for the service.

### **Supporting Lives Connecting People**

The County Council continues to plan a new approach to delivering adult social care. You may recall in my previous newsletter I mentioned that we were undertaking a second trial of the 'innovation sites' to test

new community-based ways of working. This trial has now concluded and we have been taking some time to review the findings and develop a plan to build on the great work done by staff working in the sites.

With the support of the National Development Team for Inclusion (NDTi) we are using the learning from the innovation sites to develop and implement a strengths-based, community led approach which will build on the good work done in the innovation sites. NDTi is an independent, not-for-profit organisation which is currently working with seventeen other councils across the country, helping them to implement this approach.

We will work collaboratively with people who use our services, our residents, staff and our partners to develop a shared vision for adult social care that works for everyone. I have every confidence that the skills and continued commitment of our staff will make this approach a real success.

The Committee made a number of recommendations, which will be published in due course on the Committee's <u>webpage</u>. I am currently considering my response to the recommendations.


A full analysis of the findings of the programme of engagement will be published in July on the County Council's <u>'Have Your Say'</u> website.



### **Adult Social Care Roundtable**

Since my last newsletter I have chaired two meetings of the Roundtable. These meetings host wide-ranging and lively debate between customers, carers, Members, senior officers and other key stakeholders on a variety of issues. I'm encouraged by the level of participation at each meeting. It is very powerful to listen to the experiences of our customers and carers and I'm very grateful to all those who take part.



In February, the roundtable received an insightful presentation from Dr Stephen Dyer and colleagues from the Motor Neurone Disease Association, including someone living with the disease in West Sussex. As a result, the County Council has signed up to the



Association's Charter. You can find more information about that in this newsletter. We also heard about mental health and wellbeing in migrant communities from the chair of Diverse Community Empowerment Services and received a presentation by one of our Public Health consultants on the Suicide Strategy.

At the June meeting we agreed to expand the membership of the group to strengthen the customer voice in the decision-making process. The meeting also received a comprehensive update from Healthwatch West Sussex on their recent and ongoing activity.

# **County Council adopts the Motor Neurone Disease Association Charter**

I am delighted to report that on 9 June the County Council agreed to join other local authorities across the country in adopting the



Charter of the Motor Neurone Disease Association. This provides a statement of respect, care and support that people living with Motor Neurone Disease and their carers should expect. The five points of the Charter are:

- (1) The right to an early diagnosis and information;
- (2) The right to access quality care and treatments;
- (3) The right to be treated as individuals and with dignity and respect;
- (4) The right to maximise their quality of life; and that
- (5) Carers of people with motor neurone disease have the right to be valued, respected, listened to, and well-supported.

We will ensure that the aims of the Charter are widely understood across the Council and we will follow its principles for other people with disabilities, chronic and lifethreatening conditions wherever possible.

#### **Prepaid cards for direct payments**

Plans are progressing to introduce prepaid cards, a more streamlined process for customers that wish to take their personal budget as a direct payment.

Prepaid cards are flexible, fast and convenient. People will no longer have to open and manage a dedicated bank account in order to



receive direct payments, nor send in monthly bank statements or wait for cheque

payments to clear. The card can be used in the same way as a traditional bank account by setting up standing orders and direct debits.

Prepaid cards are already used in more than 100 councils across the country and will become the County Council's primary option for people managing their direct payments. The first phase of implementation will begin in July.



#### 'The Million Pound Team'!

Congratulations to Age UK West Sussex on successfully supporting older people to access an additional £3 million of benefits during 2017-18. Age UK is a key partner in our nationally recognised Carewise care funding scheme.

Rightly known as the `Million Pound Team', the service supports older people through a dedicated Freephone advice line and community outreach workers. The team has enabled residents from across West Sussex to maximise their income through benefit checks, debt consolidation and

financial guidance to purchase help, support and care. This has helped to ensure an ever greater number of older residents can remain living at home independently for as long as they wish.

### Carers week - 11-17 June

The County Council joined forces with local NHS and partner organisations to support Carers Week, a national campaign that recognises and celebrates the vital contribution family and friend carers make to families and their communities.

This year's theme was staying 'Healthy and Connected' and encouraged carers to look after their own health needs as well as those of the people they care for.

Over 30 events took place across the county offering carers the opportunity to seek support and share experiences with other carers.
